# Complaint Redressal

The committee conducts a fair, neutral, and time-bound inquiry into the complaints submitted. Both the complainant and the respondent are heard with equal respect and confidentiality. Institutional Sensitization

The ICC organizes regular gender sensitization seminars, workshops, and policy awareness programs to instill respect and accountability within the institutional culture. Policy Evaluation & Recommendations

The committee periodically reviews SGI's internal policies regarding discipline, safety, and equality. Suggestions are submitted to institutional heads for policy revision and action.
