After consideration, fresh approval of affiliation has been granted to Subhwanti Institute of Professional Education, West Champaran, Bihar for three year LL.B and five year B.A LL.B course with intake of one section of 60 students in each course for a period of two years i.e. for the academic years 2024-2025 and 2025-2026.

The letter and approval of affiliation is subject to the payment of refundable interest fee guarantee amount of Rs. 5 lacs per course, towards fulfilling all rules, norms and guidelines of BCI. 
The guarantee fee shall be liable to be forfeited, if BCI Rules, norms and guidelines pertaining to legal education are not complied with.
